During the financial year ended 31 March 2024, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2023/24 has been carried out in accordance with this authority's needs and planned coverage. **6. Internal Control and the Management of Risk (Review by Council of the effectiveness of internal controls, including risk assessment, and Minuted accordingly).**

6.1 The Council reviewed the Risk Assessment and Management Policy at its meeting on 20 March 2023, within the 2022/23 year of account. The Council normally reviews the Risk Management/Internal Control Policies in March each year to ensure that the requirements of the Account and Audit Regulations are being met viz. that a review is completed by the Full Council, at least once each financial year, of the effectiveness of the Council's system of internal control, including the arrangements for management of risk, with the review suitably Minuted.

6.2 However, the review programmed for March 2024 coincided with the departure of the Clerk and accordingly during 2023/24 the Council did not fully comply with the Regulations in place. The review was undertaken by the Council on 20 May 2024 (in the 2024/25 year of account).

6.3 In this respect, the Council should comply with Section 4 of the Accounts and Audit Regulations 2015 and each financial year undertake a review of the effectiveness of the Council's system of internal control, including the arrangements for the management of risk, and Minute the review to evidence that it has been undertaken.

6.4 The Council regularly receives reports upon the condition of its play equipment and any remedial work required. At its meeting on 19 June 2023 the Council nominated a Councillor to act as the Playground and Health and Safety lead Councillor.

6.5 At its meeting on 19 June 2023 the Council resolved to continue an Annual Play Inspection through Mid Suffolk District Council (MSDC). The Council agreed to have the Annual Inspection as an agenda item following the inspection for 2023 due at the end of the year. The Annual Inspection was carried out on 26 January 2024 but the Parish Council was not advised of the visit until after it had taken place.

6.6 Insurance was in place during the year of account. At its meeting on 18 September 2023 the Council noted that the General Insurance and the separate Cyber Insurance/Data Protection cover were due for renewal on 1 October 2023. The Council approved the payment of £824.66 for the twelve months to 30 September 2024 based on a 3-year LTU (long term undertaking) to 2026 with Clear Councils (Insurance Management Ltd.)

6.7 Employer's Liability cover and Public Liability cover each stand at £10m. The Fidelity Guarantee cover stands at £250,000, which meets the current recommended guidelines which provide that the cover should be at least the sum of the year-end balances plus 50% of the precept/grants.

6.8 At the meeting on 16 October 2023 the Council approved the payment of £370.25 to Clear Councils for Cyber insurance.
