**FINAL MINUTES OF THE PARISH COUNCIL MEETING HELD ON
MONDAY 21st July 2025 at 7.00PM**

Present: Cllr C Tranter, Cllr C Calver, Cllr K Chapman, Cllr C Fell, Cllr F Oliver, Clerk/RFO – S Budd, 2 members of public, DC Cllr R Warboys arrived at 7.05pm, CC Cllr J Fleming arrived at 7.10pm

1 Chair welcome and to consider and approve apologies for absence

Cllr C Tranter welcomed everyone to the meeting, apologies were received from Cllr C Saunders and approved unanimously.

2 To receive Declarations of Interest on agenda items

4 To resolve the draft minutes of the Parish Council Meeting held on 16th June 2025 are a true and correct record.

7 Public Participation Session

A member of the public raised concerns regarding the Solar Farms and National Grid projects. He reported seeing two purchase orders placed on footpaths—one on Mill Street and another on Coldham Lane—and expressed unease about their proposed use. He highlighted that the village has experienced notable flooding in recent years and fears that works involving land drainage may further elevate this risk.

Additionally, he reported a 500-year-old oak tree being earmarked for removal to accommodate the proposed route, citing the environmental and heritage impact. He requested that Solar Farms and National Grid be included as a standing agenda item at future meetings and inquired about the level of support being provided by the local MP. DC Cllr Warboys responded by stating that Richard Rout is actively engaging with Suffolk County Council (SCC) behind the scenes and has sought legal advice concerning the matter.

He asked for this to be an agenda item at each meeting and asked what our MP is doing to help villages, DC Cllr Warboys said Richard Rout is working with SCC behind the scenes and have been taking legal advice.

Cllr J Fleming suggested that it would be beneficial to maintain a record of potential damage to the village's environmental assets, such as habitats and trees, to support ongoing consultation responses.

The Parish Council noted that it had not been made aware of certain purchase orders and will investigate the matter further. Additionally, two members of the council have joined the Ecopower community group and will report back following the August meeting.

8 Chair's Report

New prospective Councillor documents circulated to all Councillor's prior to the meeting, approved unanimously, they will formerly be co-opted at the next meeting.

16 Weather

Cllr F Oliver raised the issue that while the current weather is favorable, autumn and winter are fast approaching. The village has previously experienced severe flooding, resulting in some residents being stranded and temporarily accommodated in the Village Hall. In light of this, Cllr Oliver proposed that a dedicated box of supplies—such as drinks and biscuits are purchased by the council. This would serve as a small but thoughtful provision for anyone affected in the event of a future emergency.

Councillors discussed and felt it was a very good idea, Cllr C Tranter was concerned about the shelf life of the products are short, after a discussion it was agreed that £50.00 can be spent in the event of an emergency, proposed by Cllr C Tranter seconded by Cllr Fell.
